Guidance Notes

This form is to be used for the purpose of obtaining a Building Licence in respect of the Building Regulations. Planning permission may also be required for which a separate application should be made.

- A) The Applicant is the person or persons for whom the work is to be carried out. The application form must be signed by the applicant, or on his behalf by an authorized agent. Where the applicant is not the property owner an 'Owners Declaration' form must be completed and included with this submission.
- B) Wherever possible the Building Control will communicate formally via E-mail with the exception of the legal notifications. It is therefore **important for an E-mail** address to be provided on this form. Should you not wish to receive correspondence in this way please let us know.
- C) An additional copy of the proposed floor plans will be required for the Guernsey Fire and Rescue Service, if a premises is, or will become a controlled premises under the Fire Services (Guernsey) Law, 1989, as amended. An information sheet GN-15 Controlled Premises, is available on the States website for your assistance.
- D) For applications which involve commercial food preparation, an additional copy of all plans will be required for the Office of Environmental health and Pollution Regulation consultation.
- E) For all agent applications, an E-mail containing all submission documents must be sent to planning@gov.gg. The E-mail should be given the subject 'Building Regulation Application + your reference'. The E-mail text should include the site address and applicant details. Any attached documents should be given generic file names i.e. 'Application Form', 'Floor Plans' etc. including your reference numbers.
- F) **Regulation 15(10)** The report of an independent engineer, approved by the Authority, stating the engineer has checked that the design of the proposed structure or service complies with all relevant requirements must be provided if requested by Building Control; and for the purposes of this regulation
- (a) **"independent engineer"** means a Chartered Engineer who has been actively associated with a relevant discipline of engineering for at least 5 years since qualifying and has no professional or financial interest in the work that is to be checked, and
- (b) a person is regarded as having a professional or financial interest in the work if that person –
- (i) has been responsible for the design or construction of any of the work in any capacity,
- (ii) or any nominee of that person, is a member, officer or employee of a company, firm or other body which has a professional or financial interest in the work, or
- (iii) is a partner of, or is the employer or employee of, a person who has a professional or financial interest in the work.
